The new **Disability rights** chapter breaks down really complicated areas of law such as accessibility, discrimination, "reasonable accommodation", housing, education and many other related topics including your rights to use New Zealand Sign Language. **For community service providers, this chapter alone is a must-have.** Traversing areas never before covered by any legal resource in New Zealand, the chapter has been created in collaboration with disabled people and organisations from around the country.

We've overhauled our **Domestic violence, Consumer rights, Credit and debt, Neighbourhood life, Powers of attorney, Immigration** and **Refugees** chapters, and we've updated the remaining 30-odd chapters bringing them up to date with the law and improving the language in them to make them more accessible.


